## 1. Review and Confirmation of Agenda:

a. No changes to agenda.

#### 2. Chair's Report: Les

a. Les brought up the question again of whether all members are participating at an appropriate level in the garden. In order to make sure all who want to be garden members are able to do so, we are trying to avoid having any members who don't actually show up. Please message Les privately if you have any such issues and didn't bring it up the meeting.

## 3. **Budget/Treasurer**: Marcia

- a. All is good. P&L statement attached at end.
- b. We made \$280 from tomato plant fundraiser.
- c. We have a new aerial photo of the garden, and are investigating making cards with it as a fundraiser.

#### 4. Water Team: Les

- a. Les will be putting together a comparison of this year's and last year's water usage.
- b. The water pipes by the greenhouse have been rerouted.
- c. Barb reported a discrepancy of 950 gal between the water log on Wed and Thurs.

#### 5. Planting Team: Roberta

- a. Nancy Whipple has been approved to join the planting team. Welcome, Nancy!
- b. Since this year's tomato plant fundraiser was so successful, it is being considered to do a more deliberate one for next year.
- c. Crop News has been redesigned.
- d. For gopher team, please remember to change the traps every day, and keep the whiteboard up to date.
- e. It has been determined that the circular traps work better Les will be ordering some more.
- f. Brave gophers have been sighted above ground in the kohlrabi and rhubarb beds.
- g. The planting team is not in favor of a garden cat. This topic will be addressed in next month's meeting.

#### 6. Voting: Les

- a. Continued discussion of pros and cons of locking or latching the gates. Some points brought up: concern about the tone and perception of unfriendliness of locks, advantage would be to possibly avoid issues with unauthorized picking, nearby residents like to walk through garden to get to SRS.
- b. First vote taken: motion to either latch or lock the gates, and add additional signage, motion failed 7-7
- c. Second vote taken: motion to latch the gates for a trial period through October, and add additional signage, motion passed 10-4. (Note: nothing was discussed about how to evaluate results at end of trial period.)
- d. Les will send an email with proposed verbiage for sign after meeting, for discussions.
- e. The topic of voting on whether dogs (members/not members) (unleashed/leashed/short leashed) was brough up, but no motion or vote was taken. Day Leaders should continue to evaluate how their days feel about this.

#### 7. Projects: Les

a. There will be two open-house "meet and greet" days scheduled in the garden for members to attend and indicate their interest in working on projects.
